

# IMT CDL Annual Alumni Awards (2025) Guidelines for Nominations and Assessment

IMT CDL acknowledges the contribution of its alumni by conferring them excellence awards. The awards are conferred in three categories namely, Corporate Excellence awards, Entrepreneurial awards and Social/ Public Service awards.

# **Alumni Award Categories**

- 1) Corporate Excellence Awards in
  - a) Marketing and Customer Service
  - b) Operations and Supply Chain
  - c) Finance
  - d) Human Resource
  - e) Technology
- 2) Business Leadership Award
- 3) Entrepreneurship Award
- 4) Social/ Public Service Award

Special recognition for Distinguished Alumni

The eligibility criteria, the judging process, and the key timelines are explained below. Please ensure that you are familiar with the awards processes.

# **Nomination Criteria**

- 1. General:
  - The Nominee must be an IMT-CDL Alumnus with a minimum 15 years of work experience.
  - Past recipients of Alumni Award are not allowed to nominate themselves for next 5 years

#### 2. Corporate Excellence Award:

- The Alumni should be currently working in the relevant functional area.
- The nominee should be holding a senior management position in the organization.
- The nominee should have a notable achievement recognized by his/her organization.

#### 3. Business Leadership Award:

- The Alumni should be currently working in the Senior Leadership position.
- The nominee should have a notable achievement recognized by his/her organization.
- 4. Entrepreneurial Award:
  - The alumni should have a controlling stake in the organization.
  - The organization should be at least 5 years old.
  - The annual turnover of the venture should be 1 crore or more.

- 5. Social / Public Service Award:
  - The alumni should hold a position in executive committee in the Society/NGO etc.
  - The entity should be at least 5 years old.
  - The contribution towards society should be significant and quantifiable.
  - Any significant contribution to society on individual basis will also be accepted as a valid entry, if supported by documents.

# **Evaluation Process: The evaluation process will undergo three stages**

- Stage 1: Nomination Stage Stage 2: Screening Stage Stage 3: Jury Stage
  - A) Evaluation of the document submitted
  - B) Presentation given in front of the Jury.

# Award Committee

The award committee will be constituted by IMT CDL to evaluate all the nominations with supporting documents to assess the nominations and selection of awardees.

# Following the assessment of all entries, judges will identify shortlisted entries from each category and shortlisted candidates will be notified.

- Shortlisted candidates will be given the chance to present their case to the jury.
- The judges' decision shall be final and binding.

#### **General Guidelines:**

- The award entry registration form will be available from 05<sup>th</sup> January 2025 on the IMT CDL Website.
- The nominations must be filed through the link available on the website and alumni portal. Hard copy/email entries will not be accepted.
- Anonymous or incomplete nominations are not acceptable.
- The nominee is not allowed to make changes once the form is submitted.
- The Nominee should prepare and upload a 'statement of award' in 300-500 words with clear examples of how the nominee meets the selection criteria and justifies the nomination. (Refer to the evaluation criterion to prepare a statement of award).
- The alumni are expected to be physically present for the award. In case of exceptions/unavoidable circumstances, the awardee can nominate a representative from the family to receive the award.
- All application profiles and information submitted will remain the property of the IMT CDL.
- Nominees must give their consent for using their profiles along with their organisation name for publicity purposes.

- The award categories entry will open from the first week of January 2025 and close by the third week of January 2025. No entries will be entertained after the closing date. The winner will be announced at the annual Alumni Meet.
- Each applicant's submission will be limited to a single nomination category.
